I recently watched SP07 on BBC1. SP07 = Sports Personality of the Year 2007. What on earth happened to Sports Review of the Year as a title? It looks like the BBC has surrendered to the demands of the 21<sup>st</sup> Century's celebrity obsessed culture, which is a real shame.

And as for some of the winners! Take team of the year, for instance. Okay, the England rugby union team did pick themselves up magnificently to reach the World Cup Final, but they didn't actually win anything this year, until they picked up this SP07 trophy. Meanwhile, the GBR cycling team left the opposition trailing in their wake during the recent world championships, yet they were overlooked for the award. Durham County Cricket Club didn't even get shortlisted in this category, despite winning their first ever trophy, getting promotion as winners of the second division of the one day leagues and almost clinching the County Championship. Yet the Scotland football team made the shortlist - yes, that's another outfit that in the final analysis didn't achieve success. So, I'm going to get off my high horse and conduct my own Sports Review of the Year. I will try to be objective, but will probably fail, and I'm not going to set up any sort of telephone voting, as there lies the road to corruption and infamy.

#### **National/International Sport**

I'll stay brief in this area, as it won't make for pleasant reading. With a few notable exceptions (cycling, rowing, sailing to name three), the performances of our national teams and individuals were mainly marked by glorious and inglorious failure. Take the traditional leading three team sports of football, rugby union and cricket and you have a sorry tale. I won't really add to what has already been written about the rugby union team (so surprisingly close, but no cigar) and the footballers (so undeserving of the reprieve that Israel gave them, but embarrassingly unable to take advantage of it). The women's football team did get to the guarter finals of their World Cup, but were then comprehensively turned over by the USA, so no salvation for the sport there either.

Turning to cricket, the England team started their year contemplating the wreckage of their Ashes defence, and failed to spark at the World Cup or the World Twenty20. They then beat the West Indies in a Test series, but followed that up by losing to India. Their one day international fortunes are starting to turn around under new captain Paul Collingwood, and as I write this, they are still in with a shout of sharing the honours of the Test series in Sri Lanka. I still have high hopes for the cricket team, but it hasn't been a vintage year.

#### **Regional Sport**

North East England's various teams have had very mixed fortunes during 2007. I think that the progress, or otherwise, of the region's football teams is fairly common knowledge, so I won't dwell on that (as a Nottingham Forest fan, I have more than enough to worry about these days without thinking about any other club!).

Onto other sports: In basketball the Eagles have soared back to the top of the British Basketball League; over in the ice hockey arena, the Vipers' sting has been potent some of the time, but not consistently; on the rugby union pitch, the Falcons are hovering a few places above the danger zone in the league and in pole position in their European Challenge Cup pool (again, as I type this). For me, the region's outstanding club this year has been, by some distance, Durham County Cricket Club. I won't bore you by repeating what I have already written about DCCC, but simply believe that the club's achievements have been absolutely stunning, not only on the domestic scene, but also in the fact that Durham continues to be a convevor belt of exciting England players. Heady days for a club that has been an official first class county for less than 20 years.

## **Incinerator Inquiry**

Remember George Orwell's warning in the first chapter of his novel '1984' that 'The Party' has taken over all aspects of life and is intent on eradicating individuality? If so, then please be aware that our local democracy is in danger as a real 'Big Brother' looms on our horizon on the 16<sup>th</sup> and 17<sup>th</sup> January. Unlike Winston Smith, you can speak out openly and query the safety for those who live here and for the local environment of our beautiful village! Please 'stand up and be counted', don't let Big Brother win this time around.

Last year Durham County Council Planning Committee asked for public opinion concerning the proposed installation of a chimney and incinerator for the disposal of animal waste at G Bolam Foods Ltd, Salters Lane Industrial Estate. They received 224 letters of which 223 objected to the proposal, their perception being of fear and uncertainty. A further 94 signatures appeared on a petition opposing the application.

On Wednesday 16<sup>th</sup> August, 2006 fourteen members of the aforesaid Planning Committee and two other councillors made a site visit to Salters Lane to assess the pros and cons of the application before travelling to County Hall, Durham for the monthly DCC Planning Meeting. Four councillors spoke or asked questions and one councillor voted for the proposal.

The meeting resolved that planning permission be refused because: 1. There is no established need for the proposed facility, and the proposal is therefore contrary to Durham County Waste Local Plan Policies W53.

2. There would be detriment to local amenity because of public anxieties about emissions from the proposed incinerator and the controls able to be put in place. The proposal would be contrary to policies W4 and W33. All the above data comes from the Planning Committee Minutes.

This decision is likely to be overturned in January! Unless we people of Sedgefield do something the first you will hear of any noise, the first you will smell of any malodorous smell, the first you will see of the chimney spewing forth whatever as you approach on the A177 from the north will be when the plant is up and running! Then it will be too late. You still have a chance to show your opposition! A public enquiry is to be held at Sedgefield Racecourse on the 16<sup>th</sup> and 17<sup>th</sup> January, 2008 commencing at 10:00 am each day. A request for an evening session has been refused. Only by filling the room for all, or part, of each day/session will the Inspector know the strength of feeling of the local population. Please make an attempt to attend each day, it is a fact that the Inspector will have to heed the feelings of the local population. Petitions seem to have little or no clout.

If the choke points were removed in favour of "speed bumps" and no doubt, more added, they will lead to a huge increase in claims to the council for damage caused to vehicles grounding on them. Councils already spend twice as much on court fees fighting claims and then having to pay compensation for damage/injury caused, than they do repairing the roads.

Then there is the problem of the injuries caused by vehicles "bumping" over them. Professional drivers (bus/lorry etc) clock up hundreds of hours off sick with back injuries caused by speed bumps, not to mention further injuries caused to ambulance patients!

If the choke points are not doing their jobs, they could be altered to form chicanes, thereby forcing vehicles to alter their line of travel much more than they do now, making them slow down more. But please, no speed bumps. I do agree with a 20 mph limit in the village, but who will enforce it any more than the present 30 mph? Cameras have to be bought, erected, maintained and serviced. Sedgefield already pays the country's highest council tax. I for one am not keen on paying any more.

## Public Footpath? Get the Facts Right!

It never ceases to amaze us why people with such forthright views seek to reserve the right to anonymity, and complain in such a way, when they could easily have come along and spoken to us face to face.

To put the record straight, the notices did not appear on the 'footpath' as stated ; they were attached to our own fence, clearly visible from the right of way, and in fact to enable the ones placed near the A177 to be torn down, the person who did this would have had to cross the strip of land referred to, land which is in our ownership; land which is not within the definitive right of way; therefore they would indeed have been trespassing.

Before 1992 local residents had enjoyed using this track without any legal right to do so. The footpath referred to gives access along the track, which is some 3 metres wide and runs from Neville Drive to the A177, adopted by Durham County Council but not owned by them. This track does not belong to the public to do with as they will, they merely have the right to pass and re-pass along it. Over a long period of time some people have chosen to disregard the Highways Act and continue to strav from the definitive right of way. They have torn down fencing and previous notices, giving themselves, and their pets, access to East Park across this strip of land, having blatant disregard for the rights of others. What concerns us even more is that some people who use this right of way, have no consideration for

of way, have no consideration for other users and merely see it as a 'dog's toilet'. I would suggest that these 'concerned residents' come along and clean up their mess, and get their facts right before making any accusations about their 'rights'. *Mr and Mrs Wills*
