KNOW YOUR RIGHTS

Sedgefield & District Citizens Advice Bureau is an independent charitable organisation which offers clients free, confidential and impartial advice on all subjects through its fully trained advisers. Last year the CAB dealt with over 33,000 enquiries from the Borough's residents.

Most of the enquiries, 32%, were to do with Social Security enquiries - benefit payments. Advisers are able to sort out difficulties with claims, help fill in forms and check that people are receiving their full entitlement. They are also able to help clients with Money Advice.

Debt is a problem for millions of people struggling to make ends meet. The CAB say 'tackle it early, don't let bills pile up and seek help in drawing up a budget and realistic payment plans'. The CAB has a specialist Money Adviser, funded through the Community Fund, who can help negotiate with creditors. Last year 47% of enquiries were about Money Advice.

In addition Sedgefield & District CAB offers advice on Employment problems, Housing, Consumer and Legal matters. To get in touch simply call into any of the advice sessions below and an adviser will be please to help.

The Annual Meeting in May was well attended. Elaine Thomson was elected as the President. The resolutions to be debated at the National Annual Meeting in Brighton, in June, were discussed W.I. Members from England and Wales will be voting on support for small abattoirs and the improvement of regulations governing the importation of food.

The quiz team of Alison Hodges, Barbara Hudson, Alice Nixon and Margaret Pegler were placed fourth in the county competition.

The next meeting will be on Wednesday, 5th June, at 7.15pm, in the Parish Hall, when we will learn more about Age Concern. The competition will be a piece of memorabilia from the Queen's Coronation.

Sedgefield Community Appraisal - progress report

In the May edition of Sedgefield News it was reported that Chris Cox and Associates have been appointed to carry out a Community Appraisal, covering Sedgefield, Mordon and Bradbury. The aim of the Appraisal, commissioned by Sedgefield Development Partnership is

- a) To develop a profile of the communities, covering such issues as the state of the environment, health conditions, crime rates, unemployment rates, housing trends and conditions, facilities and services available etc.
- b) To find out the views of local residents and other stakeholders about what are the key issues and opportunities in the community
- c) To review good practice elsewhere and funding opportunities
- d) To draw up a list of potential action that could improve the quality of life for local people

Action so far has included:

- a walkabout around the communities with local reps
- discussions with partnership members
- a series of interviews with local stakeholders, including local authority officers, councillors, local businessmen, school reps, voluntary organisations, community groups and individuals
- initiation of a household survey that hopefully all have now seen and will complete and return!

Some of the issues that are arising from this process to date include:

- Sedgefield has a weakening economy with less jobs, especially with the closure of the hospital which used to employ around 2000 people, now 80. New opportunities exist, however, through the development of the Netpark and making the most of tourist opportunities
- Services are reasonably stable at present and it is vital that this situation is carefully monitored
- The range and variety of local housing is good but improvements could be made especially in relation to an ageing population and the need to provide starter homes to encourage younger people to stay in the area
- Facilities and opportunities for young people are a priority, ranging from children's play areas, to youth facilities
- Transport issues including the need for traffic calming and improved parking in the town centre
- Pockets of 'hidden poverty' exist, especially amongst the elderly
- Generally maintaining the pleasant and clean environment is vital
- The future of the Parish Hall a purpose built, sound-proofed, fully accessible building could supply a much wider range of groups and activities
- In Bradbury and Mordon there is a need to look at issues around through traffic and the need for traffic calming

All of these issues and others will be developed further via the analysis of the questionnaires and through focus groups that will follow in June.

Minutes (Condensed) of Meeting held on Tuesday, 9th April 2002

Prior to meeting starting the Chair called for a minute's silence in memory of The Queen Mother!

- · A presentation from Ritchie Austin, Officer with Sedgefield Borough Community Force was delivered before the start of the evening's agenda.
 - Apologies received from Colin Bellwood, Joy Nolan, Sandra & Alan Coyle, Ann Oliver.
 - Minutes of Previous meeting were accepted.
- Matters Arising: Travellers Camp. No feedback had been received on this issue. Julia Bowles to follow up.
 - · Alan Sowerby Memorial Award: Chair reported on meetings with the Heads of both Primary Schools and their enthusiasm. It is intended that Joy Nolan (Hon Sec) will present both Trophies to the appropriate School, and introduce it to the Pupils!
 - Accommodation for meetings of Exec. Committee is now available in the Police Station.
 - First Responders: The cheque for £112 to be presented to the Spennymoor Croup is being with held. as They are not fully operational yet.

Treasurers Report: Accepted.

Secretary's Report: There was nothing to report.

Village Constable: P.C. Todd circulated the Police Crime Report, as follows: -

March 2002. Total of 121 incidents were reported to Police during March.

41 Crimes (Recordable) include: -

4 Burglaries (dwelling): 5 Burglaries (other); 7 thefts: 12 Criminal damage; 2 Motor vehicles crimes;

5 Assaults; 4 Bilkings (failing to pay for petrol @ filling station)

Points of note: 7 damages @ The Gables, person arrested & charged.

23rd March- Bogus Dynarod Official (distraction) burglary @ Wykes Close.

4th March Cleveland Police pursued vehicle through Sedgefield from Stockton and police vehicle was rammed person arrested.

10th March- show homes @ Winterton broken into & white goods stolen.

Crime Prevention Officer's Report: Neil Langthorne apologised for the problems with the "ring-around" system, as members had not received warnings of crimes in the area, and explained the new arrangements to ensure that there was facility to "ring-around" to cover most situations. He also submitted a map of the Village, detailing the 50 street contacts- stating that coverage appeared fairly even at first inspection.

Neil then advised members that it was hoped the new Co-ordinator would be at our next meeting.

He also advised that the next "crime wave" would probably be "shed" burglary. He recommended that good quality locks, window screens etc. be fitted and kept in position and locked.

Bogus Callers (Distraction Burglary) is still a big problem. Residents must be on their guard- auld check credentials.

Constitution: The Chair advised the meeting that there were a number of amendments to be made, before the Document could be submitted to the members, probably at the next meeting.

Any Other Business: The Chair advised members that the initial cost of printing the first Neighbourhood Watch Newsletter was too high, but would be reviewed urgently.

A raffle was held. a bottle of wine & two glasses. This raised £21 from the members.

The winner was Mr Alan Bilinge.

- · Chair reported that our place at Sedgefield show, on Saturday 10th August had been booked. He also reminded the members that the show is our principle means of fund raising, and asked for assistance to provide Tombola prizes; also help on the "day"
- Roy Smeaton raised the issue of the white Peugeot car, dumped on the A177. It t had been there for more than 3 weeks! P.C.Todd explained the Police position regarding the law. It was agreed to follow this issue up at the next meeting NEXT MEETING 11th June 2002. 7p.m.

<u>Walking School Bus</u> <u>Sedgefield Girl Guide Rangers</u>

A group of young girls, belonging to the above, are involved in the Square Mile Project, organised by Durham Agency Against Crime and sponsored by Northumberland Water. Their project is to start up a Walking School Bus in Sedgefield.

The Walking School Bus is a method of safely delivering your child to school. Starting and finishing at an agreed spot, an adult will accompany the children at all times, collecting or dropping off children at strategic points along the way.

The benefits to your child are numerous. The main points are:-

- The children are ready to learn earlier than a child who rides to school in a car;
- It is healthier. Research into benefits of regular exercise, in the form of walking, are well documented;
- It is a safe way to get your child to school;
- The benefits to the environment are evident in fewer car journeys to school.
- The local residents suffer less disturbance;
- The concept, if implemented, would be supported by the school.

After the Time Team

The Time Team have gone from the East Park, what now? Fiona Macdonald, the Durham County Archaeologist says that further excavations are not envisaged, at least not in the near future. What people may see during the next few months are people wandering over the Park with geophysics equipment. The geophysics tests before and during filming were incomplete and the full extent of the Roman settlement has still to be determined. Also, any further tree planting will require archaeological work to ensure that no buried remains are damaged.

The Time Team have gone away to work on the material discovered during the dig and will return to Durham County Council early next year with a dossier of their findings. After that, many of the artefacts discovered on the site will be gathered together and put on display in the village. The Friends of Hardwick are hopeful that a permanent exhibition area will be included in the proposed Visitor Centre in the West Park, which forms part of the Heritage Lottery bid.

News from Bradbury and Mordon
